Waiver and Release of Liability

In consideration for receiving access and meals at the PGA Magazine Event titled PGA Magazine Leadership Club Conference (also called "PGA Magazine Event") at no cost to take place at PGA of America National Headquarters, November 29-December 1, 2026, from Great Golf Resorts of the World, Inc. ("PGA Magazine Event"), its related events and activities, I, acknowledge, appreciate, and agree that:

A. There is a risk of property damage or personal injury from the activities involved in the "PGA Magazine Event", including, but not limited to, the potential for death or bodily injury, and while particular skills, equipment, and personal discipline may reduce the risk, the risk of serious injury does exist. Risk include infectious diseases, including but limited to Coronavirus/COVID-19, Flu (Influenza), Norovirus and others as identified by the National Foundation for Infectious Diseases known and unknown.

B. I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, BOTH KNOWN AND UNKNOWN, EVEN IF ARISING FROM THE NEGLIGENCE OF THE "RELEASEES" (DEFINED BELOW) OR OTHERS AND ASSUME FULL RESPONSIBILITY FOR MY PARTICIPATION.

C. I willingly agree to comply with all stated and customary terms and conditions for participation in the "PGA Magazine Event". If, however, I observe any unusual or significant hazard or risk during my participation in the "PGA Magazine Event", I will remove myself from participation.

D. I, FOR MYSELF AND ON BEHALF OF MY HEIRS, PERSONAL AND LEGAL REPRESENTATIVES, AND NEXT OF KIN, AGREE TO ASSUME ALL RISKS AND TO RELEASE, HOLD HARMLESS AND COVENANT NOT TO SUE GREAT GOLF RESORTS OF THE WORLD, INC. ("GGRW") OR ITS OFFICERS, DIRECTORS, EMPLOYEES, AGENTS, ATTORNEYS, OR AFFILIATES (COLLECTIVELY, THE "RELEASEES"), FROM AND FOR ANY CLAIM, LOSS OR LIABILITY THAT I MAY HAVE, INCLUDING FOR BODILY INJURY, DEATH OR PROPERTY DAMAGE, WHETHER CAUSED BY NEGLIGENCE OR CARELESSNESS OF THE RELEASEES OR OTHERWISE.

E. I intend by this Waiver and Release to release in advance, and to waive my rights and to discharge all of the Releasees from, all claims, losses or liabilities for personal injury, including, but not limited to, death or bodily injury, or property damage that I may have or claim to have, or which may hereafter accrue to me, as a result of my participation, even though that liability may arise from negligence or carelessness on the part of the Releasees. I understand and agree that this Waiver and Release is binding on my heirs, personal and legal representatives, and next of kin.

I HAVE READ THIS WAIVER AND RELEASE OF LIABILITY, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE ASSUMED RISKS AND GIVEN UP SUBSTANTIAL RIGHTS BY AGREEING TO IT, AND AGREE TO IT VOLUNTARILY WITHOUT ANY

INDUCEMENT AND WITH THE INTENTION OF BEING LEGALLY BOUND HEREBY.
